Subject: Consolidated Scrutinizer's Report on remote e-voting pursuant to the provisions of Section 108 of the Companies Act, 2013 (Act) read with Rule 20 of the Companies (Management and Administration) Rules, 2014 and amendments thereto for the 88th Annual General Meeting of The Rajagiri Rubber and Produce Company Limited held on Friday, September 26, 2025 at 11:00 A.M at W-21/674, Beach Road, Alappuzha – 688012.

We, V Suresh Associates, Practising Company Secretaries, have been appointed by the Board of Directors of The Rajagiri Rubber and Produce Company Limited, (the Company) as a Scrutinizer for the purpose of scrutinizing the remote e-voting/ voting through Ballot Papers at the AGM venue and ascertaining the requisite majority, on the resolutions contained in the notice to the 88th Annual General Meeting (AGM) of the members of the Company.

The Notice dated 11th August, 2025 under Section 102 of the Act were sent to the Shareholders in respect of the below mentioned resolutions passed at the Annual General Meeting of the Company.

The Public Advertisement with respect to dispatch of notices and conducting of voting through electronic means was published in an English newspaper "Financial Express " in all editions and in a vernacular newspaper "Mangalam" Alleppey Edition on 2nd September, 2025

The management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and the Rules relating to voting through electronic means on the resolutions contained in the Notice of 88th Annual General Meeting (AGM) of the members of the Company.



Our responsibility as a Scrutinizer for the e-voting process is restricted to presenting a Scrutinizer's Report on the votes cast "in favour" or "against", in respect of the resolutions stated below, based on the reports generated from the e-voting system provided by M/s. Central Depository Services (India) Limited ('CDSL'), the authorized agency to provide e-voting facilities, engaged by the Company.

The members of the Company as on the "cut-off" date i.e. 19th September, 2025 were entitled to vote on the resolutions (items no. 1 to 3 as set out in the notice of the 88th AGM of the Company.)

Further to the above, we submit our report as under:-

Remote E-voting:

- i. The e-voting period remained open from **Tuesday, 23rd September, 2025** (9.00 A.M. IST) to **Thursday, 25th September, 2025** (5.00 p.m. IST) (both days inclusive).
- ii. The votes cast under remote e-voting facility were thereafter unblocked in presence of two witnesses who were not in employment of the Company.
- i. The Corporate member who had participated in the remote e-voting had provided scanned copy of the resolution passed at their Board of Directors Meeting for authorization to exercise their votes through e-voting.

Voting through Ballot Papers at the AGM venue:

- i. The Company had provided the facility for voting through ballot paper at the AGM venue and members, who have not cast their vote by remote e-voting, were allowed to exercise their right to vote at the meeting.
- ii. The Ballot papers in Form MGT-12 as per Section 109(5) of the Act and rule 21(1)(c) of the Companies (Management and Administration) Rules, 2014 were distributed to the shareholders present. The shareholders cast their votes in the ballot box kept at convenient places in the venue.
- iii. The Ballot papers were collected and diligently scrutinized. They were also reconciled with the records maintained by the Company and the authorizations/proxies lodged with the Company.

Thereafter, the consolidated results containing, inter alia, list of Equity Shareholders, who voted "for", or "against", in respect of the each of the resolutions that were put to vote, were generated from the e-voting website of M/s. Central Depository Services (India) Ltd, (i.e.) www.evotingindia.com was prepared.
